## Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

This is further to our letter dated 15<sup>th</sup> May, 2018, informing you that Aditya Birla Money Limited ("ABML"), subsidiary of the Company and Aditya Birla Commodities Broking Limited ("ABCBL"), a step-down subsidiary of the Company (and wholly owned subsidiary of ABML) were in the process of filing applications before the National Company Law Tribunal, Ahmedabad Bench, for approval of a Scheme of Amalgamation for the Merger of ABCBL with ABML, under Sections 230-232 of the Companies Act, 2013.

We now wish to inform you that Hon'ble National Company Law Tribunal, Ahmedabad Bench, vide its order dated 14<sup>th</sup> November, 2018 has sanctioned the aforementioned Scheme of Amalgamation of ABCBL with ABML, which has been made effective on 14<sup>th</sup> December, 2018.

In view of the above amalgamation, ABCBL ceased to be a step-down subsidiary of the Company with effect from 14<sup>th</sup> December, 2018.
